Ambassador Al-Mughairy has also served as the head the Public Liaison Service of the UN's Department of Public Information; she was principle officer of the electoral assistance division, for which she traveled throughout Lesotho, Sierra Leon, Ethiopia, and many other countries. Prior to that, she was chief of the news distribution, which was an information arm for advising the Secretary General of the UN on events around the world. She started working at the UN as information officer for International
